ORDER TO IMPOSE AN ADMINISTRATIVE PENALTY

1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center is a licensed service provider (licence # SP16033) under the Act.

On May 15, 2018, the Superintendent of Financial Services (the "Superintendent") issued a Notice of Proposal to Impose An Administrative Penalty (the "Notice") against 1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center, in the amount of \$2,500 for contravening section 15 of Ontario Regulation 90/14.

The Notice was served on 1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center by registered mail on May 25, 2018. 1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center had 15 days after being given the Notice to request a hearing before the Financial Services Tribunal (the "Tribunal") in accordance with subsection 441.3(5) of the Act.

The Registrar of the Tribunal has confirmed that, as of June 12, 2018, no request for hearing has been filed by 1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center or anyone on its behalf.

ORDER

An Administrative Monetary Penalty in the amount of \$2,500 is imposed on 1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center.

TAKE NOTICE THAT 1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center will be receiving shortly an invoice from Ontario Shared Services, a part of the Ministry of Government and Consumer Services, with information as to where and how to make the payment. 1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center must pay the Administrative Monetary Penalty no later than 30 days after the date of the invoice.

If 1945201 Ontario Corp. O/A Doctor Med Rehabilitation Center fails to pay the Administrative Monetary Penalty in accordance with the terms of this Order, the Superintendent may file the Order with the Superior Court of Justice and the Order may be enforced as if it were an order of the Court. An Administrative Monetary Penalty that is not paid in accordance with the terms of an order imposing the penalty is a debt due to the Crown and is enforceable as such.
